On Friday, December 7, 2018, Judge Mendoza entered an *Order and Permanent Injunction* in favor of the Federal Trade Commission and the Florida Attorney General and against the Defendant Kevin Guice. The order, which is posted elsewhere on this site, finds that Kevin Guice, through his various companies, engaged in a pattern of unlawful conduct that defrauded consumers in violation of state and federal law. Judge Mendoza:

- Permanently enjoined Kevin Guice from engaging in any telemarketing activities of any kind;
 - Found Kevin Guice liable to the FTC for \$23,099,878.02; and
- Directed Kevin Guice to turn over to me the property identified on the attached exhibit, so that I can sell it.

Kevin Guice can file an appeal from Judge Mendoza's ruling. He has sixty days to do so. In my view, Judge Mendoza's ruling is sound and very unlikely to be reversed on appeal. Even if Kevin Guice appeals, he still will be required to turn over the personal property identified on the exhibit, unless he is able to obtain an order staying, or delaying, the effectiveness of Judge Mendoza's ruling. This is very unlikely.

After I receive the items of personal property I will sell them at a public auction, which likely will occur in January, 2019. Further details will be posted on this site.

Still pending before Judge Mendoza is my motion seeking an order finding that the Guices' homestead property is subject to a "constructive trust" in favor of the receivership estates. In Florida, an individual person's "homestead," or primary residence, is exempt from creditors, which means that typically it cannot be taken to satisfy debts owed by the individual person. There are exceptions to this doctrine. For example, there is no homestead protection where funds obtained through fraud or egregious conduct were used to invest in, purchase or improve the homestead. In my Receiver's Motion to Compel disgorgement of Assets from Defendant Kevin Guice and his Spouse, Shannon Guice, to Impose Constructive Trust, and for Other Equitable

Relief, I have argued that Kevin Guice transferred almost \$8.6 million from his various companies to a bank account that he owns jointly with his spouse, and that the Guices used a portion of this \$8.6 million to purchase and improve their homestead. I have requested that the Court impose a constructive trust over the homestead, and that it authorize me to sell it. Hopefully, Judge Mendoza will grant the motion in the near future.
